- Task Force for OCDA contributions to OMEA Conferences (Gayle Walker, Robert Jones)
  - A report was given by Walker and Jones.
  - Recommended that a request for reading sessions need to be made more than a year in advance
  - o Conferences nationwide is "downsizing"
  - o Committee monies for OMEA was reported to be very low

- Concern about industry led sessions over quality educational sessions was discussed
- O Jones sent Ayling the following for inclusion in the minutes: Notes presented at OCDA 2007 Winter Meeting:

OCDA Reading Session wasn't requested until late this year-early in the fall. Tell the next Conference Chair now that you wish to have a reading session.

Being late this year caused a conflict in planning and securing music.

The chair of the conference has assistants from each area - Band, Chorus, Orchestra. Each year attempts are made to choose a balance upper and lower level performance groups, if possible. Applications go to the choral chair and that person chooses a committee to hear the tapes. Each group was identified by a number to maintain anonymity this year.

Tracking of Band, Orchestra, and Choir-oriented attendees can be done to determine how many of each area attend. Linda said the lack of choral attendance has been puzzling to Convention chairs. Two tendencies-choral directors perceiving the conference was more bandgeneral music intensive and the past chairs observing a lack of choral attendees- have resulted in a lack of choral programming perhaps. She felt the OCDA and choral directors need to make their needs and interest known to conference chairs and at the state level of OMEA. Linda also felt she was attempting to rectify this by having a balanced number of clinician headliners in each of the major areas.

There are two band and two choral headliners this year. The vocal headliners are Jeff Johnson from UK and James Jordan from Westminster. Committee chairs

(DBringman) recommended the clinicians and session topics.

The Choral Section should notify the Cincinnati Chair, Bob Bass, now as to our wants and concerns for the 2008 Conference.

A recommendation is up to make a two-year vacuum so groups can't perform two years in a row. This could be voted on this fall.

- President-elect Walker will contact Bob Bass (2008 OMEA conference chair) to request reading sessions for that conference.
- Repertoire Notebooks from Reading Sessions (Amy Chivington)
  - Distributed to R&S Chairs and will be available at the summer conference
