- A. Guest Speaker: Roger Hall, Executive Director of OMEA, Director of the Foundation for Music Education in Ohio
 - OMEA is a 501(c)6 organization, essentially a business league (like a chamber of commerce)
 - OMEA is the only music association of the 50 that refers to itself as an "Education" association, not an "Educators" association
 - Roger's primary mission is about establishing collaboration; the organization is more about what its people bring to the association, not what the association does for them
 - Questions posed by OCDA board members were answered. Roger

emphasized that OMEA tries to provide something for everyone, but not everything for anyone.

- Offer was made to OCDA members to attend the 2009 OMEA Conference in Cleveland at the MENC member rate, without joining MENC; reciprocally asked that OCDA
- Verbal commitment from Chanticleer to be the opening act at OMEA conference in Cleveland (2009) on Thursday evening at Music Hall; tickets will be sold to the concert to the public at \$20; every ticket sold by a choral group in Northern Ohio(or all of Ohio), will get a return of \$5 to that group.
- Bill Davis will be the content chair for 2009.
- Offered over two years for OCDA to submit six to eight proposals for clinicians, OMEA will approve four, and OCDA will pay for those clinicians, OMEA will offer four additional slots for OCDA interest sessions beyond the current reading sessions + full page ad in OMEA program or TRIAD (2009-2010); proposal in writing to be distributed to board via email
- To the best of Roger's knowledge, a new rubric for adjudicated events is still being explored by the AE committee; **Tina will follow up with Ann Usher regarding the status of this new rubric**
