• Request for two Otterbein students to serve as assistants (same as 2007):

Duties:Monday, 3:00-9:00<br/>Monday nightHelp with registration, set up of chairs, etc<br/>Stay in dorm, one in each dorm, to serve as liaisonbetween chaperones and Robyn who is hosting guest conductor a few doors away. No<br/>responsibilities other than to direct parents around campus, answer logistical questions, and<br/>connect those in the dorms with the emergency forms in Robyn's care.

Tuesday, 8:30-11:00 Assist with rehearsal if needed. Be available to run errands

	as needed. Should be able to be free by mid-morning.
Tuesday night	Stay in dorm again.

**Stipend**: \$150/student, meals paid for with honor choir (Tues AM – Wed noon) and two nights in private dorm room paid.

- Request to offer same process and amount for financial aid/scholarship as 2007.
- Do we have non-profit status? If not, when is it expected? "Otterbein business office has recently raised the issue of the possible need for summer camps to pay state sales tax of 6.75%. This would not impact not-for-profit groups. [Summer activities] will contact [Robyn] as soon as they receive a final decision on whether we are accountable for state sales tax.
- As required by Otterbein, will we have the following? "All groups, including day camps, are required to have insurance designating Otterbein College as "additional names insured," with a minimum limit of million dollars per occurrence and two million aggregate. Insurance may be purchased as a rider to the Otterbein policy. Please contact me if you are interested in learning more about this.
- Also, as required by Otterbein, note for Kent: All groups will be required to submit a deposit of roughly 10% of their estimated cost, not to exceed \$1,000.

3 pm, Sunday February 24, at Summit United Methodist Church, Columbus.

Directed by Leah Edmondson (University Baptist Church) and Sheena Phillips (Summit United Methodist Church / OCDA Community Choir R&S Chair)

The idea is to enable people who sing in small church or community choirs, who would not generally have the opportunity to perform major works, to do so by combining with other singers. The event is open to any singers or choirs in the Columbus area (or beyond) who can come to at least 2 of the 3 Sunday rehearsals, as well as the dress rehearsal.

Participating churches will contribute to these costs, but a few hundred extra dollars would be helpful. (Collection proceeds will go to Neighborhood Services Initiative, which provides food and clothing to low income people in the area.)

Participation in *Missa Luba* will be open to anyone in the Columbus area (or beyond). Participants so far include the Columbus Women's Chorus and the Dublin Singers, with interest from the International Ensemble of the Columbus Children's Choir. The aim is to assemble a really good crowd of community singers, and add plenty of noise from drums.
