- Newsletter Report (Ron Blackley)
 - Ron distributed new deadlines for the next two years for newsletter submissions
 - Some concern was voiced about timing of issue arrival. Ron explained that he is in the queue for about 30 days with Ashland's printing service. Suggested that perhaps deadlines be moved up to account for this delay. Ron will advertise anticipated publication date, not arrival date.
- Webmaster Report (Luke Rosen)
 - Luke is stepping down as webmaster; introduced James Vaughn as new webmaster

- James anticipates that it will take to the end of the summer to get up to speed to bring the site current
- Unger noted that it would be helpful to have the schedule in a more easily identified section of the website, separate from the registration form

• R&S Chairs

- Jones collegiate choral festival was March 1; tentatively planned for February 21, 2009 at Worthington UMC. Many thanks to OSU for hosting well in 2008. Bob reported the need for additional advertising to make the event even more successful in the future – perhaps in the *Triad*.
- o Ward extended "Men" to include all males. Held an event in May with an 8th grade choir called "Boys Night Out."
- o Mathias Children's choir area doing well with the Children's Honor Choir at summer conference. No anticipated need for additional events.
- Ruff MS trying to improve participation in solo & ensemble by hosting a similar event at Olentangy Schools to include neighboring school districts, using an improved rubric for feedback
- Sneed Women's chorus festival was very successful and challenged Ward to do a similar festival for men's choruses. Nearly all schools that participated were small local schools. Advance preparation was poor, but the event was successful nonetheless.
- Phillips two performances in 2008 were very successful. Community performance of Faure *Requiem* was successful and well attended, raising \$800 for *Neighborhood Services*. Choral Festival included five area choirs culminating in *Missa Luba*. Excellent attendance, outstanding performance, and raised over \$1000 for *Doctors without Borders*.
- Raber similar solo & ensemble event to MS hosted at Oak Harbor. Planning to extend to additional schools in 2009.
- Bradley Music in Worship organized a youth choir event for United Methodist Churches from West Ohio Conference, culminating in a performance in New York City.
- Davis September 19-21, 2008 will host and participate in the Northern Ohio Hymn Festival. Clinicians are David Orr, Anton Armstrong, and John Ferguson. Masterclasses will be held in organ and choral techniques on Saturday. Festival choir is Sunday (performance at 4 p.m., rehearsal at 2 p.m.). Registration is still open.
- Wolfe (Ward reporting) All-Ohio Boychoir event was held at Van Wert on May 3. Bob noted that he is the longest tenured boychoir director in Ohio at four years.

- o notebooks will be stored at Otterbein after the conference
- OCDA Reading Sessions at OMEA (Ben Ayling)
 - o reminder to start working to find new titles; deadline same as last year (November 15?)
- OCDA collaboration with OMEA Conferences (Gayle Walker)
 - Walker seated on OMEA board currently as representative of OCDA
 - o we are continuing our relationship with OMEA in suggesting clinicians and providing up to total \$2500 for clinicians
 - We need to remind OMEA conference planners that we are to receive recognition of our financial participation in providing choral sessions by way of inclusion of OCDA name/logo in advertising and in individual sessions.
 - Vocal pledge by Roger Hall for OCDA members to be able to attend OMEA conferences at member rate regardless of their member status in OMEA – Walker will watchdog this issue
 - We need to discuss the breakdown of choral categories for planning as instrumental instructors break down their categories for the sake of planning at our Fall meeting
- Children's Honor Choir (report attached); highlights:
 - o significant increase in registration this year over the past few weeks
 - o all five satellite areas have been successful
 - o 155 singers are registered this is the maximum we can accommodate
 - o five of the participating teachers are new members of OCDA/ACDA because of the honor choir
 - seven full scholarships awarded, four partial scholarships awarded (no cost to OCDA for partials)
 - o substantial income and expenses, but net profit to OCDA is anticipated to be just over \$4,500
 - o our budget is higher than most states, but the on-campus housing option is an equalizing factor in terms of cost to families
 - o still need to focus recruitment in southeast and northwest Ohio
 - o hope to continue scholarships in 2009

 - Consensus was to wait until the conference issue of *Triad* deadline is October; Ayling will ask his son to design, Gil willing to assist as needed in design of ad and logo

- Sponsorship (Gayle Walker/Kent Vandock)
 - Kent suggested establishing a cap on annual sponsorship totals not to exceed \$2500

- Membership Concerns (Ben Ayling)
 - ACDA Leadership Conference is taking place again, and Ben will attend this summer. He plans to involve the region chairs in some changes to promote membership.
 - \circ Next year's conference registration will include a place for registrants to include county and R & S areas of interest
- Sponsorship of Collegiate Choral Festival (Bob Jones)
 - o Advertising budget provided for 2009 festival

 Discussion around whether the inclusion of television spot would set a precedent for other R & S events that would become cost prohibitive
